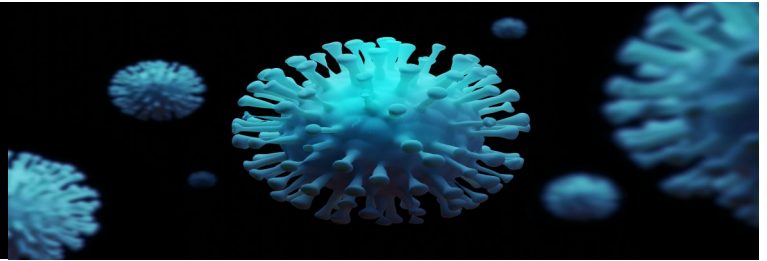

Dear Morrow County Community Partners:

These are the latest COVID-19 updates as of today.

Local Situation Update

As of today, there are 107 total cases of COVID-19 in Morrow County. (103 confirmed and 4 probable)

These cases include 82 males and 25 females. The age range for these individuals is 14-81 years old, with an average age of 39 years. 8 of these cases have had to be hospitalized, and 0 case is still recovering in the hospital. There has been 1 Morrow County death from the disease. 89 of the total cases are now considered recovered from COVID-19, and 17 cases are still ill.

Of the 107 total cases, 54 cases, are related to the Morrow County Correctional Facility.

Statewide Situation Update

As of today, there have been **35,984** cases of COVID-19 in Ohio, including **2,206** deaths. All of Ohio's 88 counties are now reporting at least one case of COVID-19. These cases range in age from **less than 1 year** old to **109** years old, with a median age of **49** years. As of 2:00 pm today, there have been **398,066** total Ohio residents tested for COVID-19.

The latest Director's Public Health Order, issued on May 28, 2020, is the **Order to Test Residents and Staff of Nursing Homes**. This order requires all residents and staff of LTC facilities to be tested for COVID-19. [Learn more.](#)

As of today, the CDC reports **1,787,680** total COVID-19 cases across the United States, and **104,396** total deaths from the disease. Cases have been reported in all **50** states, and 5 U.S. territories.

Responsible Restart Ohio

As each business sector is allowed to reopen, they must follow the operating requirements set by the state.

- On May 1, 2020, medical facilities reopened. The healthcare guide can be found [here](#).
- On May 4, 2020, manufacturing, construction, and distribution businesses, and general office environments reopened. Their operating requirements can be found [here](#), and [here](#).
- On May 12, 2020, consumer, retail, and services businesses reopened. Their requirements can be found [here](#).
- On May 15, 2020, personal care businesses may reopen. These businesses include: hair and nail salons, tanning facilities, barbershops, and day spas. Their operating requirements are [here](#).
- On May 15, 2020, massage businesses and tattoo/piercing businesses may reopen. Their operating requirements can be found [here](#).
- On May 15, 2020, restaurants and bars may reopen for **outdoor dining**. Their requirements are [here](#).
- On May 21, 2020, restaurants and bars may reopen for **dine-in service**. Their requirements are [here](#).
- On May 21, 2020, campgrounds may reopen. Their operating requirements are [here](#).
- On May 22, 2020, horseracing may reopen, without spectators.
- On May 26, 2020, gyms and fitness centers may reopen. Their operating requirements are [here](#).
